I hereby waive, release and forever discharge NEXUS LAN, its organizers, sponsors, staff and volunteers, from any and all liability for any personal injuries or property damage that one or both of us may sustain as a result of, or during, our participation in any NEXUS LAN events, including any personal injuries or property damage that I/we believe may have been sustained as a result of the negligence, in whole or in part, of NEXUS LAN.
